#### Rebecca Campbell

## Health Improvement Lead (Tobacco), NHS Greater Glasgow & Clyde National Tobacco Control Adviser, Scottish Government

Rebecca has worked with Smokefree Services since 2003 – originally as part of the team overseeing the stop smoking groups in the City, then eight years as trainer and is now the lead for Tobacco Control work across NHSGGC. Her main areas of responsibility are development and co-ordination of stop smoking services within the acute, pregnancy and prison settings, development and delivery of tobacco and generic health behaviour training and focussing on smoking and inequalities. Rebecca is also currently working at Scottish Government in the Tobacco Control Team on a 2 year secondment. Rebecca graduated with a BSc (hons) in Biology from the University of St Andrews in 1997 and is currently studying for a Master of Public Health at the University of Glasgow.

#### Chief Inspector Alastair Muir Specialist Crime Division, Safer Communities Scottish Crime Campus, Police Scotland

Alastair has served in both the Metropolitan and Strathclyde Police Services prior to the formation of Police Scotland. The majority of work has been in the operational environment within Greater Glasgow policing division. That said, in 2008 he relocated to Thailand where he managed a Child Protection and Human Trafficking project, returning to policing in 2012. His current role within the National Safer Communities department involves responsibility for a range of prevention activities across Scotland.

#### **Dominic Munro**

#### Head of Better Homes Division, Scottish Government

Dominic is currently responsible for policy areas such as fuel poverty, energy efficiency, homelessness, the private rented sector, and social housing. Prior to this, he has led a number of divisions including Justice Analytical Services, in which role he led the development of Scotland's first over-arching Strategy for Justice, and Communities Analytical Services Division. Dominic has also led the Scottish Government's central economic team and remains a Senior Economic Adviser in the Government Economic Service. He has also worked on the development of Scotland's international strategy, leading the government's first strategy for strengthening relations with China. Dominic has worked in various Whitehall departments on areas including emerging markets and globalisation, for HM Treasury; as a specialist in Middle East and African risk in the UK's export finance agency; and on oil and regional policy in the Department for Trade and Industry.

#### **Professor David Tappin**

#### Professor of Clinical Trials for Children University of Glasgow, Honorary Consultant Paediatrician NHS Greater Glasgow and Clyde

Professor Tappin qualified as a doctor 1980 and as a paediatrician 1986. He achieved a Masters in Public Health 1998, followed by a Masters in Clinical Trials 2012. His main interest is Public Health Research. Having started with descriptive epidemiology - HIV sero-prevalence in childbearing women in Scotland, he moved on to observational case controlled studies – Sudden Infant Death Syndrome. More recently Professor Tappin has led clinical trials of non-drug interventions: Motivational Interviewing for Smoking Cessation in Pregnancy; and Financial Incentives for Smoking Cessation during pregnancy.
